Making a Rapid Response Request

ELRCs 8, 9, & 10

WHAT HAVE YOU DONE?

Observations/Tracking, Ages & Stages Questionnaire, (ASQ3 or ASQ:SE2), Conversations with Family, etc

CHILD HAS NO IFSP/IEP DIAGNOSIS

Be prepared with child's name, DOB, Parent/Caregiver contact information and permission, what is happening now, what has been tried, and any other supports in place.

MEET WITH RESPONDER

Rapid Response will provide observation within 48 hours and offer feedback, strategies, and resources. Program will allow time for teacher to meet outside of classroom.

PLEASE NOTE

Rapid Response is NOT a diagnostic evaluation and is not a fast track for getting a child one-on-one services (a BHS). Please try to adjust staffing so that the responder and teacher can meet privately to discuss challenges. Avoid discussing challenges in the classroom in front of children.

Every situation is different. The earlier you contact your coach with concerns, the sooner appropriate resources can be shared and utilized. Behaviors that challenge us are not always "the child" but may be a result of the environment and/or teacher-child expectations. Your STARS Team is here to support you, your program, and your children and families.
